CUF will also upgrade all 5 thermostats to state of the art. We expect this to be completed no later than July 30, 2023. CUF also needs to set an additional amount aside for the replacement of another HVACunit.

The CUF Board approved this bid. We are waiting for the installation as this proposal is being prepared.

Since this is a contract for professionals, there is no opportunity for participation.
Additional comments:
The average life of an air conditioner is 17 years. Furnaces have an average life of 25 years. When an air conditioner fails, replacement of the furnace is required.
We are on "borrowed time" with the remaining 4 air conditioners. We can expect to replace all four within the next 5 years.
Furnaces can be repaired with parts from salvaged furnaces removed from service. A furnace failure does not require replacement of the attached air conditioner.
With the imminent replacement of shingles on the roof, there will be no money available for the current HVAC replacement.
Given the anticipated failure of another unit in the near future, this request includes the price of another HVAC unit.
