Summary Description with Estimated Timeline (Including approximate completion date) *

Convert the existing storage room currently used by RE into a single stall bathroom. Plumbing already exists in an adjoining wall from the nursery bathroom. This is a low cost, low impact INTERIM solution to offer a gender neutral bathroom at CUF. Completion date would be approximately 4 weeks from start date.

Plumbing work (includes toilet + vanity)= \$7,000 Drywall, painting, and finishing= \$7,000 Total =\$14,000

It is our belief that in order for CUF to effectively champion the social justice issue of gender expression, ALL spaces must be welcoming and inclusive. Creating bathroom facilities that are open to people of any gender, or "gender neutral," is an important and critical way to show full welcome and inclusion.

Strengthen bonds with the Carbondale? SI community? *

The issue of gender expression is an important social issue that CUF should embrace and support. Creating bathrooms that bring a sense of security, comfort, and respect is an opportunity to show the community our commitment and support for this issue.

Impact the Fellowship? *

Functions of the impacted space may be impaired short term during construction, however the long term impact will be to provide for an additional bathroom for the entire congregation. More importantly, it will be an opportunity for CUF to enter into a larger educational dialogue about creating safe spaces and could assist us in achieving the ultimate goal of converting all bathrooms to gender neutral.

Contribute to the sustainability of the congregation for future generations? *

Creating safe places for everyone by embracing the fluidity of gender expression will prove to the community our good will and intent to be inclusive. By doing so, younger generations are more likely to feel welcome at CUF and seek us out to become actively involved with the congregation.
